

## **Tuition Scholarship Program Terms and Conditions**

**Effective Date:** January 28, 2026

Please read these Terms and Conditions (“Terms”) carefully before applying for the University of Wisconsin-Parkside Tuition Scholarship Program (“Scholarship”). By submitting an application, you (“Applicant”) agree to be bound by these Terms. Scholarships are limited and awarded based on the eligibility requirements.

**Eligibility:** The Scholarship is open only to individuals who:

- Meet all admission requirements for, and be admitted to, an Eligible Program at University of Wisconsin-Parkside.
- Are legal residents of the United States.
- Are at least 18 years of age at the time of application.
- Are enrolled in Spring I, Spring II, Summer I, or Summer II 2026.
- Have not previously enrolled in courses at the University of Wisconsin-Parkside for the MBA program.
- Have not previously received this Scholarship.

### **Selection and Notification**

- Scholarship awards are non-transferable and may not be substituted for cash or other benefits.

### **Scholarship Award Details**

- The Scholarship will be awarded to eligible students based on availability of funds.
- The Scholarship will be awarded as a tuition credit, in increments of One Hundred Dollars (\$100) per credit or \$200 per course conditional upon enrollment in one course in the Eligible Programs within the time frame of January 28, 2026, to July 6, 2026.
- The credit will be applied for each term that the student enrolls in at least one course for eligible terms of Spring I, Spring II, Summer I, or Summer II 2026.
- Maximum enrollment of 2 courses per term for a maximum \$400 total Scholarship per eligible term.
- Students are eligible for the credit within the eligibility period up to \$400 per term for a total credit up to \$1,600.
- To receive the Scholarship, the recipient must:
  - Enroll in at least 1 course of the Eligible Programs within the time frame specified (January 28, 2026, to July 6, 2026).
  - Remain in good academic standing as defined by the University of Wisconsin-Parkside.
- Failure to meet these requirements will result in the forfeiture of any remaining Scholarship funds.

- MBA with a Concentration in General Management
- MBA with a Concentration in Accounting
- MBA with a Concentration in Data Analytics
- MBA with a Concentration in Finance
- MBA with a Concentration in Global Management
- MBA with a Concentration in Human Resources
- MBA with a Concentration in Marketing
- MBA with a Concentration in Program and Project Management
- MBA with a Concentration in Supply Chain Management

**Additional Terms**

- The University of Wisconsin-Parkside reserves the right to verify eligibility and to disqualify any applicant found to have provided false information.
- The University of Wisconsin-Parkside may modify or cancel the Scholarship at any time, for any reason, with or without notice.
- The Scholarship is subject to all applicable federal, state, and local laws and regulations.
- Any tax liability resulting from the Scholarship is the sole responsibility of the Scholarship recipient.
